In reference to above, as per provisions laid down in 'General Terms & Conditions' and as per Pre Bid Meeting held on 09/09/2015 at 1:00 PM at Paschimanchal Unnayan Parshad Office, Bankura in presence of the representatives of different Software development companies, following addendums, changes and clarifications are hereby made in the Expression of Interest document under reference:

- I. It is hereby clarified that "It will be a cloud based deployment" (Ref: page 5, Scope of the said document) giving priority to the security of the system.
- II. Work flow includes (Ref: page 6 of said document):

 3. Scheme Monitoring
 4. File Management
- III. Subscription based Open Source Technologies will be used for this project (Ref: page 1)
- IV. Phase wise project monitoring to be included.
- V. Receipts & Payments to be generated by the system.
- VI. Ref: page 2, Qualifying Criteria point No. 5 may be read as "The organization should have successfully executed at least two software development projects with subsequent maintenance, each with value not less than Rs. 10 lac within the last three years".
- VII. Consortiums in any means are not allowed for this entire project.
