Work Description: *Providing Consultancy Services for preparation of Detailed Project Report (D.P.R) for construction of major bridge over Kansai River in between Kantabera & Bamundih village within Garafusra G.P under Purulia-I Development Block in the District of Purulia.*

The Chief Executive Officer, Paschimanchal Unnayan Parshad, Bankura invites item rate e-Expression of Interest for the above work from reputed consultancy firm with proven track record and at least 5 years of experience in the relevant field for providing consultancy services for planning, designing, architecture, preparation of estimates for construction work on the guidelines of CPWD / Govt. norms with necessary vetting of structural part & architectural part with detailed quantity estimate from competent authority.

1. In the event of e-filing intending bidders may download the documents from the website directly by the help of Digital Signature Certificate (DSC). Technical Bid & Financial Bid both will be submitted concurrently, duly digitally signed, in the Website <https://wbtenders.gov.in>. EoI document may be downloaded from website & submission of Technical Bid/ Financial Bid as per time schedule. The documents submitted by the bidders should be properly indexed & self attested with seal. The bidder shall carefully go through the documents and prepare the required documents, and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated locations of Technical Bid. He needs to fill up the rates of items / percentage in the BoQ, downloaded for the work, in the designated Cell and upload the same in designated location of Financial Bid. The documents uploaded are virus scanned and digitally signed using the Digital Signature Certificate (DSC). Tenderers should specially take note of all the addendum / corrigendum related to the tender and upload the latest documents as part of the tender.

2. *Length of the proposed bridge is near about 175 mtr.* Before submission, the intending bidders should make themselves acquainted thoroughly with the local conditions prevailing at site by actual inspection of the site and taking into consideration all factors and difficulties likely to be involved in the execution of work in all respect including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local labour and market rate prevailing in the locality etc. and no claim, whatsoever, will be entertained on these account afterwards. In this connection intending tenderers may contact the office of the undersigned, concerned with the work between 11.30 hours to 16.30 hours on any working day prior to date of submission of tenders.

3. *Scope of Work:* The work would include preparation of details Architectural Drawings, Structural Designs including preparation of details estimate of the proposed scheme with bill of quantities. The detailed estimate is to be prepared on the basis of P.W.D Schedule of Rates with current corrigendum. In case of non-scheduled items, analysis of rates should be provided.

Besides the above, you have to take the following major responsibilities:-

- Architectural Designs including preparation of details of plans, elevations, sections, perspective drawings, architectural details etc.
- Structural Design of the proposed bridge including vetting of the same by any Competent Authority to be decided by Paschimanchal Unnayan Parshad.
- Any change in Architectural and other Design of the proposed bridge as may be suggested by any Expert Panel must be done by free of cost.
