- 9] All works have to be done according to specification and drawing approved by the authority and as per direction of Executive officer P.S.
- 10] No consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
- 11] Bitumen will be supplied by the contractor with his own arrangement subjected to submission of valid document of I.O.C.
